Sub : Grant of No objection to return to India (NORI) to Pakistani  
nationals living in India on Long Term Visa (LTV) -  
clarification regarding

Sir,

I am directed to say that this Ministry has been receiving representations from Pak nationals seeking clarification as to whether State Government can grant NORI visa to those Pak nationals whose proposal for grant of Long Term Visa (LTV) is under consideration with the Government of India.

2. As per extant instructions, State Government is competent to grant NORI permission to Pakistani nationals whose LTV has been approved by the Ministry of Home Affairs. However for change of route, the State Government concerned is required to forward the proposal to the Ministry of Home Affairs with their recommendation. Powers to grant NORI and change of route in respect of a Pakistani national whose LTV has not been approved so far by the Central Government vests with the Ministry of Home Affairs and these powers have not been delegated to the State Governments/UTs/FRROs.
3. In all cases which are within the powers of Ministry of Home Affairs as explained above, the applicant has to submit the request for grant of NORI/change of route to the FRO concerned who will forward the request to the Ministry of Home Affairs with his recommendations/remarks. The applications will not be entertained in the Ministry of Home Affairs directly and it is once again clarified that in all such cases, the applications are to be submitted to the FRO concerned who will forward the same to the Ministry of Home Affairs with his recommendations/remarks alongwith copies of relevant documents i.e., passport (with visa page), residential permit etc.
4. Necessary instructions may be issued to all FROs in your State/UT accordingly.
5. This issues with the approval of the competent authority.

Subject: Grant of long term visa to minor children of Pak  
nationals who entered into India on the joint passport  
of their mother and not possessing their own passports.

Sir,

The Indo-Pak Visa Agreement, 1974 as amended from time  
to time does not provide for the grant of long term visa to the  
Pak nationals. However, instructions have been issued from time  
to time, in the past providing for grant of long term visa to  
the following categories of Pak nationals :-

- (i) Member of minority communities in Pakistan (Hindus and  
Sikhs);
- (ii) Pak women married to Indian nationals and staying in  
India;
- (iii) Indian women married to Pak nationals and returning  
due to widowhood/divorce and having no male member to  
support them in Pakistan.

2. Possession of valid passport is a pre-requisite for  
considering grant of long term visa to pak nationals. However,  
in light of the difficulties faced by Pak nationals in getting  
their passport extended/renewed, this Ministry vide its letter  
No.12011/26/97-F.III dated 04.08.1997 asked the State  
Governments to consider cases of extension of stay in respect of  
Pak nationals belonging to the above three categories especially  
those belonging to minority communities in Pakistan without  
insisting on their producing renewed/fresh passports. However,  
copy of the acknowledgement receipts for having submitted their  
passports with the Pakistan High Commission for renewal/issue of  
fresh passports is to be obtained invariably.

3. The attention of the Central Government has been drawn  
by the various State Governments/UT Administrations towards the  
problems faced by minor children of Pak nationals who entered  
into India on the passport of their mothers and not possessing  
their own passport subsequent to their mothers acquiring Indian  
citizenship, in getting long term extension of visa.

4. The Government of India has considered the problem  
faced by such minor children of Pak nationals in getting  
extension of visa on long term basis and it has been decided  
that such minor Pak children may be granted long term visa and  
necessary endorsements may be made on their residential permits.  
However, two photocopies of the passports of their mother  
bearing the names of such minor children as well, should  
invariably be obtained and one copy should be enclosed with the  
Residential Permit and the other be kept on the record to  
facilitate the processing of their requests for grant of Indian  
citizenship when they become eligible for the same.
